Dear Current or Prospective Student,

The Higher Education Opportunity Act (HEOA) of 2008 and our institutional accreditation agency require that Institutions make available to their students information regarding graduation and placement rates, including the methodology and time frame applicable to the rates.

To follow is the 2016 annual report graduation and placement rate data for the school.

This information is compiled based on the requirements of our institutional accrediting body. Information is maintained, tracked, and updated in our student data base system.

The methodology and time frame applicable to these rates is as follows:

**Institutional Accrediting Body: Accrediting Commission of Career Schools and Colleges (ACCSC)**

The reporting period is July 1 through June 30. Graduation and placement statistics are calculated per program. Placement benchmarks are minimum 70% per program. The graduation benchmark varies by program and is based on the program length.

Although the reporting period is July 1 through June 30, dates used for the calculation will cover class start dates prior to this period. The dates are determined based on program length in months and allow for students to complete the program within 1.5 times the program length and 3 months to find employment.

Graduation rates are calculated by dividing total graduates by students available for graduation. Placement rates are calculated by dividing employed graduates by total available graduates for the reporting period.

Placements are determined by a graduate working in their field or a related field. Placement information is verified with the employer.

As per ACCSC standards, the rates listed below may exclude students who fall into one of the following categories: death, incarceration, active military service deployment, the onset of a medical condition that prevents continued enrollment or employment, or international students who have returned to their country of origin.
