Institutional Accrediting Body: Accrediting Bureau of Health Education Schools (ABHES)

The reporting period is July 1 through June 30. Placement statistics are calculated per program. Placement rate and licensure/certification exam pass rate benchmarks are a minimum of 70% per program.

The placement and examination pass rate are determined by using the ABHES required method of calculation, for the reporting period, as follows:

Placement Rate = (P) / (G-U)

P = Placed graduates

G = Total graduates

U = Graduates unavailable for placement

Examination Pass Rate = (GP) / (GT)

GP = Total graduates passing examination (any attempt) GT = Total graduates taking examination Pass Rate = Percentage of students passing examination

Placed graduates are defined as those employed in a position wherein the majority of the graduate's job functions are related to the skills and knowledge acquired through successful completion of the training program. Placement information is verified with the employer.

The licensure/certification exam rates listed below are for programs that may require licensure or certification to obtain employment. The pass rate listed below is the rate as last reported to ABHES. This rate is based on the reporting period described above and may not represent the calendar year pass rate. If you have questions regarding your program's pass rate, please consult with the Dean of Education.

Unavailable is defined as students are who are unavailable for employment and fall into one of the following categories: healthrelated issues, military obligations, incarceration, continuing education status, or death. As a result, students may be excluded from the rates listed below.
